SAFETY RULES

SPEED LIMIT ON TERMINAL:

**** 10 MPH ****

- Shut trucks off when in warehouse
- All drivers must stay a safe distance away (not less than 20 feet) from any area where forklifts are being operated
- Trailer doors are to be secured prior to backing into loading ramp
- Chock wheels at loading dock prior to loading or unloading
- Yield right of way to forklifts
- Stay in lanes. DO NOT cut through cargo staging areas
- Be observant and watch movement of cargo handling equipment
- Be alert for other trucks
- Follow instructions of terminal personnel
- Trucks must be **locked at all times while left unattended** for security reasons
- **Drivers will be required to wear reflective safety vests**
- **Drivers not wearing vests will not be loaded.**
- **The FMT office has vests available**



SECURITY NOTICE

A Transportation Worker Identification Credential card (TWIC) is required for all personnel to have unescorted access to secure areas of maritime facilities.
